In order to qualify for the New Century Scholarship a student must complete the following:

1. Earn an associate degree (or complete the Math and Science Curriculum) with a college **GPA of a 3.0** from an approved Utah public college or university **by the date of your class's high school graduation**. Or if you graduate from high school early, by the time your class would have graduated.
You may earn your associate degree from: Dixie State University, Salt Lake Community College, Snow College, Southern Utah University, University of Utah (Equivalent Certification), Utah State University, Utah State University Eastern, Utah Valley University, or Weber State University.
 2. Earn a minimum high school cumulative **GPA of 3.5**.
 3. If you were home schooled, or will earn your high school diploma from an online school, you will be required to submit an ACT score with a minimum of a **26 composite score**.
 4. Enroll in **15 credits fall semester** following your high school graduation at one of the following Utah institutions of higher education:

Brigham Young University (Provo)	Dixie State University	Southern Utah University
University of Utah	Utah State University	Utah Valley University
Weber State University	Westminster College	
- Note: If you do not enroll in 15 or more credits at an eligible institution, you must submit and be approved for a deferment. For more information regarding the deferment process visit our website, www.newcenturyscholarship.org.
5. Complete **STEP ONE** of the application process by filling out the 2014 New Century Scholarship application and mailing it by **February 3, 2014**. **The application for the New Century Scholarship is on the reverse side of this document.**
 - Faxed or emailed applications are **NOT** accepted.
 - Late or incomplete applications are not considered.
 - Applications must be **SIGNED** by the student
 - You will receive a letter indicating the receipt of your application.
 - ◇ Should your application be valid, this letter will include instructions related to step two of the application process, including what documentation you will need to submit by **September 2, 2014**.
 - ◇ If you have not received a response regarding the submission of your application by April 1, 2014, you need to call our office at 801-321-7221 to inquire about the status of your scholarship, or you risk forfeiting the scholarship.
 6. Complete **STEP TWO** of the application process. Instructions related to step two are provided directly to the applicant as mentioned above in item 5.

Once you have completed the application on the reverse side, print, sign and date it. Then mail it to the address listed above. **You are encouraged to keep a record and copies of all documents you submit for the New Century Scholarship. You may also want to consider mailing the application materials via certified mail.** It is the applicant's responsibility to confirm receipt of the application and related documents.

ALL APPLICATION MATERIALS MUST BE POSTMARKED BY FEBRUARY 3, 2014.

The award amount for the New Century Scholarship program is determined on an annual basis and is subject to legislative funding and the total number of qualified participants within the program. Therefore, the award amount may be reduced, may vary from year to year, and is dependent on when the recipient is enrolled in college.
