In order to qualify for the New Century Scholarship a student must complete the following:

- 1. Earn an associate degree (or complete the Math and Science Curriculum) with a college **GPA of a 3.0** from an approved Utah public college or university **by the date of your class's high school graduation**. Or by the time your class would have graduated, if you graduate from high school early. You may earn your associate degree from: Dixie State University, Salt Lake Community College, Snow College, Southern Utah University, University of Utah (Equivalent Certification), Utah State University, Utah Valley University, or Weber State University.
- 2. Earn a minimum high school cumulative **GPA of 3.5**.
- 3. If you were home schooled, or will earn your high school diploma from an online school, you will be required to submit an ACT score with a minimum of a **26 composite score**.
- 4. Enroll in 15 credits fall semester following your high school graduation at one of the following Utah institutions of higher education:

Brigham Young University (Provo)

University of Utah

Weber State University

Dixie State University Utah State University

Westminster College

Southern Utah University

Utah Valley University

Note: If you do not enroll in 15 or more credits at an eligible institution, you must submit and be approved for a deferment for more information regarding the deferment process visit our website, www.newcenturyscholarship.org.

- 5. Complete STEP ONE of the application process by filling out the 2015 New Century Scholarship application and mailing it by February 2, 2015. The application for the New Century Scholarship is on the reverse side of this document.
 - Faxed or emailed applications are **NOT** accepted and late or incomplete applications will not be considered.
 - Applications must be SIGNED by the student applicant.

After you have completed the application on the reverse side, <u>print</u>, <u>sign</u> and <u>date it</u>. Then mail it to the address listed above. You are encouraged to keep a record and copies of all documents you submit for the New Century Scholarship. You may also want to consider mailing the application materials via certified mail. It is the applicant's responsibility to confirm receipt of the application and related documents.

Once your application is submitted you will be sent an email indicating that we have received your application. An initial review will be conducted to determine that your application is valid. You will receive a letter by April 15, 2015, regarding the outcome of the initial review. If your application is valid, your letter will include instructions related to step two of the application process, and what documentation you will need to submit by **September 1, 2015**.

- If you have not received a response regarding the submission of your application by April 15, 2015, you need to call our office at 801-321-7221 to inquire about the status of your scholarship, or you risk forfeiting the scholarship.
- 6. Complete STEP TWO of the application process. Instructions related to step two are provided directly to the applicant as mentioned above in item 5.

ALL APPLICATION MATERIALS MUST BE POSTMARKED BY FEBRUARY 2, 2015.

The award amount for the New Century Scholarship program is determined on an annual basis and is subject to legislative funding and the total number of qualified participants within the program. Therefore, the award amount may be reduced, may vary from year to year, and is dependent on when the recipient is enrolled in college.
