






# **First Credential**

## **A Shared Goal**

To ensure every Utah high school student graduates with a credential that prepares them for college and the workforce by uniting state K-12 and higher education agencies in a comprehensive, collaborative effort.

### **Utah's Educational Attainment: 2023**



**61.7%** of adults in Utah have a post-high school degree, certificate, or certification

Only **1 out of 29 counties** in Utah reached 60% attainment

**37.3 percentage point gap** between Utah counties with the highest and lowest attainment rates (Summit: 63.4%; Uintah: 26.1%)

## What is a First Credential?

### HB 260, lines 199-211

- Concurrent Enrollment (12-18 credits or prescribed coursework)
- Industry Recognized Credential
- Youth Apprenticeship Program (300 hours completion)
- Technical College certificate completion
- Career & Technical Education pathway completion

## H.B. 260 Bill Provisions



Creates Oversight Committee



Requires Master Plan to scale statewide



Calls for master credential process & committee



Provides methods for ensuring industry alignment



Stipulates collaboration



Provides grants, incentives & scholarships



Ensures transferability & credential stackability



## Where we've been: Admit Utah 1.0

- Oct 17, 2024 July 8, 2025
- Total users: 234,083
- Sessions: 46,934
- Avg time on site: 1min. 31sec.
- See where you can go: 11,375
- Find your fit: 4,050
- Total outbound click: 19,821

- 2024 Utah College Application Week Outcomes
- Participating high schools: 148 (8%1)
- Total apps submitted: 50,016 (7.5%1)



## Where we are going: Admit Utah 2.0

Objectives


- Move beyond guaranteed admissions and provide students direct access to colleges and universities
- Enhance Admit Utah to be a more comprehensive experience
- Integrate college-going practices into K-12 education

### Outcomes

- Accomplishes statutory obligation (Utah Code § 53B-1-402(2)(r)) for single application and direct admissions
- Reimagined Admit Utah user experience including real-time identity validation
- Establishes data sharing agreements between USBE & USHE
