





### **Proactive Ideas: FSA ID**

- Work with students to complete their FSA ID before the FAFSA opens.
- Provide extra credit opportunities for students who complete their FSA ID (at home or school).
- Maybe host events during school (students) or after school (families).
- Pair your FSA ID events with Utah College Application Week.
  - \*Our office will not be coordinating any official FSA ID-type events nor providing any official assistance

The hope for all of this is that when your students complete the FSA ID in the fall, they won't have to worry about it while filing the FAFSA in the spring.

- Register as a partner UCAW high school to receive list


### **Origins of Affirmative Action in Higher Education**

- What is affirmative action?
- Regents of the University of California v. Bakke 1978
  - Ruled unconstitutional to use racial quotas but could use race as one factor to accept applicants
- 9 states already had a ban on affirmative action before the Supreme Court of the United States (SCOTUS) ruling

- Blue: Banned affirmative action prior to SCOTUS ruling
- Dark blue: Reinstated affirmative action prior to SCOTUS ruling
- Grey: Do not have state policies



## Supreme Court of the United States Ruling

- University of North Carolina at Chapel Hill & Harvard College
- On June 29, 2023, SCOTUS struck down the use of race as a factor in college admissions
- The implications of this decision change the way admissions decisions will be made at very selective colleges

### Impact on Utah

#### State level

• For Utah, the ruling will not impact admissions at public colleges and universities.

#### Institutional level

- Utah public colleges and universities do not consider an applicant's race or ethnicity when making admissions decisions.
- Colleges may consider various student identities (e.g., disability, firstgeneration) in scholarship applications.


### **Official USHE Statement**

"While the recent decision by the Supreme Court to strike down affirmative action policies may be causing concern among students and families throughout the nation, it is important to note that this ruling will not impact admissions at public colleges and universities in Utah. Unlike some other institutions across the country, Utah public colleges and universities do not consider an applicant's race or ethnicity when making admissions decisions.

Though we are still assessing the broader impacts, if any, the court's ruling may have on our institutions, the Utah System of Higher Education remains dedicated to creating welcoming and inclusive environments that encourage and celebrate the unique backgrounds of every student."
